City of Leander Fees

- Application Fee: \$200 (credited toward permit fee)
- Plan Review
 - ❖ up to 3000 sq. ft.: \$50
 - ❖ 3000 sq. ft. or greater: \$0.05 per sq. ft.
- Building Permit: \$0.15 per sq. ft. (total foundation/floor) (\$40 minimum)
- Plumbing Permit: \$0.15 per sq. ft. (total foundation/floor) (\$40 minimum)
- Mechanical Permit: \$0.15 per sq. ft. (total foundation/floor) (\$40 minimum)
- Electrical Permit: \$0.15 per sq. ft. (total foundation/floor) (\$40 minimum)
- Permanent Power: \$40
- Fence Permit: \$10
- Tap Fee (⁵/₈ inch)
 - Service lines are installed by City:
 - Water: \$840 (includes water meter installation)
 - Wastewater: \$750
 - Service lines are in place, only City inspection required:
 - Water: \$340 (includes water meter installation)
 - Wastewater: \$100


Phasing Plan





Phase 2 Section 3 76 – 70' Lots for Sale






Location Map


Amenity Center Layout

Offering Guidelines

- Property For Sale: 42 or 76 70' paper lots
 Sections 2-3 and 2-4
- Asking Price:
 Minimum offer price to start at \$53,000 per lot + \$2,500/Lot Amenity Center Fee
- Purchase Terms: Seller requires all cash close
- Letter of Intent: Non-binding LOI must be delivered by TBD. Upon mutual execution of LOI, parties will endeavor to enter into binding purchase and sale agreement

- Deposits: Initial deposit of \$50,000 shall be paid to KB Home at the time of an executed purchase and sale agreement and shall be fully refundable during the feasibility period. An amount = 10% of the total sale price (less the \$50,000 already deposited) will be due at the end of feasibility.
- Feasibility Period: Buyer shall have no more than 60 days in which to investigate all aspects of the property. Feasibility Period will begin on the effective date of the Purchase and Sales Agreement.
- Closing:
 No more than 30 days after end of feasibility
